Our mission is to protect the rights and address the needs of persons in forced or voluntary migration worldwide and support their transition to a dignified life.

Today, refugees and internally displaced people have exceeded 68.5 million people worldwide for the first time in the post-World War II era, and we find the need for our work grows exponentially. Globally, our steadfast mission is required in more places and for more people than ever before. Young people continue to flee persecution around the globe-- children in Central America, in Eritrea, in Sudan literally running for their lives. The growing anti-immigrant and refugee sentiment masked under security concerns pushes against even modest resettlement of refugees in a growing number of countries and many routes to seeking asylum are closed. New and historic conflicts remain unresolved and the number of persons in need of protection only expands.

At USCRI we refuse to surrender our century old identity of compassion to the oppressed and persecuted – we remain standing strong! As a dynamic organization we have adapted and grown to serve victims of human trafficking, addressing the needs of refugees in the US; the repatriated children in El Salvador and the ongoing efforts to build new lives in freedom for refugees and immigrants across the country. Last year we bid farewell to our retiring President & CEO Lavinia Limon and after a national search the USCRI Board of Directors invited me to lead the agency.

Thanks to the over 1,800 donors who supported our work in 2017. Your support of our work is critical because refugees and immigrants are not just numbers. Each life we touch is a life saved and working together will enable us to transform countless lives.



