The U.S. Committee for Refugees and Immigrants (USCRI), established in 1911, is a nongovernmental, not-for-profit international organization dedicated to addressing the needs and rights of refugees and immigrants. USCRI, working with its affiliates, provides legal, social, and health services to refugees, unaccompanied migrating children, trafficking survivors, and other immigrants in all 50 states, Mexico, El Salvador, and Honduras. USCRI advocates for the rights of refugees and immigrants both nationally and globally, helping to drive policies, practices, and law.

MESSAGE FROM OUR CEO



Dear Friends,

The U.S. Committee for Refugees and Immigrants (USCRI) is pleased to share with you some of our accomplishments from Fiscal Year (FY) 2022. During the year, we witnessed the impact of the U.S. withdrawal from Afghanistan and the Russian invasion of Ukraine. Both events led to masses of people fleeing their homes, and our work at USCRI was dramatically impacted.

With the fall of Kabul in August 2021, our work for FY 2022 began with an immediate need to assist our Afghan allies. USCRI and its affiliates resettled over 10,200 Afghan arrivals, 2,800 refugees, and 1,000 special immigrant visa holders. We also provided medical coverage to 91,074 Afghan evacuees through the Health Benefits at Safe Havens program.

As we were resettling Afghans, Russia invaded Ukraine and we began assisting Ukrainians who were arriving in the United States. We provided employment assistance, translation services, and legal and social services to Ukrainians who moved to the United States by their own means or through the Uniting for Ukraine program.

Along with our assistance to Afghans and Ukrainians, USCRI continued and expanded programming for other populations both in the United States and overseas. USCRI received so much support from individuals and organizations that we were able to open five new offices in Richmond, VA; Dallas, TX; Atlanta, GA; Denver, CO; and Detroit, MI. These offices allow us to expand our reach to assist immigrant and refugee communities needing free and low-cost legal and social services. We also opened an office in Honduras to begin a Livelihoods program for youth returned from the United States.

We were fortunate in FY 2022 to provide a wide range of services. We advised 2,805 legal clients; provided care and housing for over 700 unaccompanied girls at our residential care home Rinconcito del Sol; completed 1,127 home studies and provided post-release services to 9,721 unaccompanied children; offered legal and social services to 2,336 clients at our office in Tijuana, Mexico; and assisted over 2,400 trafficking survivors.

Along with providing direct services, we advocated to improve the opportunities of persons in forced or voluntary migration worldwide. Our Policy & Advocacy team successfully urged the Biden Administration to designate Temporary Protected Status for Ukraine, Afghanistan, Ethiopia, and Cameroon.

OUR PROGRAMS



CHILDREN'S SERVICES

USCRI provides home assessments and case management services to unaccompanied migrating children. When migrating children arrive in the United States without a parent, they initially stay in federal custody. The most vulnerable children receive home assessments prior to release to ensure they are released to a safe environment. Eligible children also receive follow-up services to help them integrate into their new communities. In FY 22, USCRI and its partner network served nearly 12,000 children and their sponsors across the country with home assessments and follow-up services.



RESIDENTIAL CARE

Rinconcito del Sol ("a little corner of sunshine") provides a safe and welcoming temporary home to girls who have arrived in the United States unaccompanied by their parents and without immigration status. USCRI offers medical care, mental health services, English language training, and education to the girls and addresses their unique needs, such as reproductive health, sexual abuse, sex trafficking, and domestic violence. Girls participate in specialized programming, including art therapy, gardening and recycling activities, musical instruction, and equine therapy. In FY 22, Rinconcito del Sol cared for over 700 girls.



REFUGEE PROGRAMS

USCRI and its national affiliates assist newcomers in achieving self-sufficiency. In FY 22, through its refugee programs, USCRI resettled over 10,200 arrivals under the Afghan Placement and Assistance program. USCRI also resettled over 2,800 refugees and 1,000 special immigrant visa holders through the Reception and Placement Program. For over 1,250 of the most vulnerable refugees, including nearly 600 Afghans, USCRI provided comprehensive case management under the Preferred Communities program. And more than 1,050 refugees were placed in their first jobs in the United States through 32 partner agencies across the country.

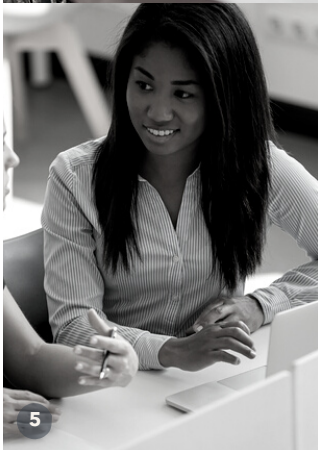
TRAFFICKING SERVICES

USCRI serves foreign national adult victims of human trafficking through the Trafficking Victim Assistance Program (TVAP) and child victims through Aspire: Child Trafficking Victim Assistance Demonstration Program. USCRI provides person-centered, trauma-informed, comprehensive case management to these populations through a nationwide network of service providers. USCRI served over 2,400 trafficking survivors in FY 22.



LEGAL PROGRAMS

USCRI provides low-cost and pro bono legal services to low-income refugees and immigrants in 14 USCRI offices and over 20 affiliate offices across the United States. Programs in FY 22 included Afghan legal services, representation for unaccompanied children, victims of crime programming, naturalization assistance, and legal representation for Ukrainians. In FY 22, USCRI served 2,805 legal clients. The agency filed citizenship applications for over 140 lawful permanent residents (LPR) and reunited 15 families through family-based petitions and consular processing. For unaccompanied children, USCRI obtained special immigrant juvenile status for 30 youth, asylum for five children, and LPR status for an additional 20 youth.



REFUGEE HEALTH SERVICES

Refugee Health Services support and develop health and wellness initiatives for refugees. USCRI's Medical Screening Program assists newcomers with a healthy start in the United States. Other programs include Refugee Medical Assistance, Refugee Health Promotion, Mental Health Awareness Training, and Behavioral and Psychosocial Support for Afghans. In FY 22, USCRI served 18,689 clients through Refugee Medical Assistance. USCRI also provided health coverage to approximately 91,074 Afghan evacuees. Services ranged from obstetrics, surgical interventions for acute and chronic conditions, orthopedic, cardiology, and pediatric and rehabilitative services.

OUR PROGRAMS



POLICY AND ADVOCACY

USCRI's Policy and Advocacy Team leads the development of the organization's position on legislation; federal, state and foreign government policies; litigation; and the root causes and conditions of migration. Policy analysts bring migration issues to the attention of policymakers and organizations of influence. They serve as experts on refugees, asylum, unaccompanied children, climate migration, and human trafficking. In FY 22, USCRI conducted a field visit to Tijuana to report on the situation for Ukrainians at the U.S.-Mexico border; published 24 Policy and Advocacy Reports; successfully advocated for Temporary Protected Status for Afghanistan and Ukraine; and conducted 96 meetings with bipartisan House and Senate offices.



INTERNATIONAL

USCRI has offices in Mexico, El Salvador, and Honduras. The Mexico team collaborates with USCRI's San Diego legal office to provide legal counsel and "Know Your Rights" presentations at migrant shelters. USCRI's Livelihoods program in El Salvador provides psychosocial services and technical training to returned youth and links them with employment opportunities. In FY 22, the Mexico team assisted 255 clients to prepare for asylum interviews, represented 49 individuals in refugee proceedings, advised 386 clients about U.S. immigration law, and assisted over 1,646 individuals with legal entry into the United States. USCRI reintegrated 70 Salvadoran returnees and began its Honduras operations.

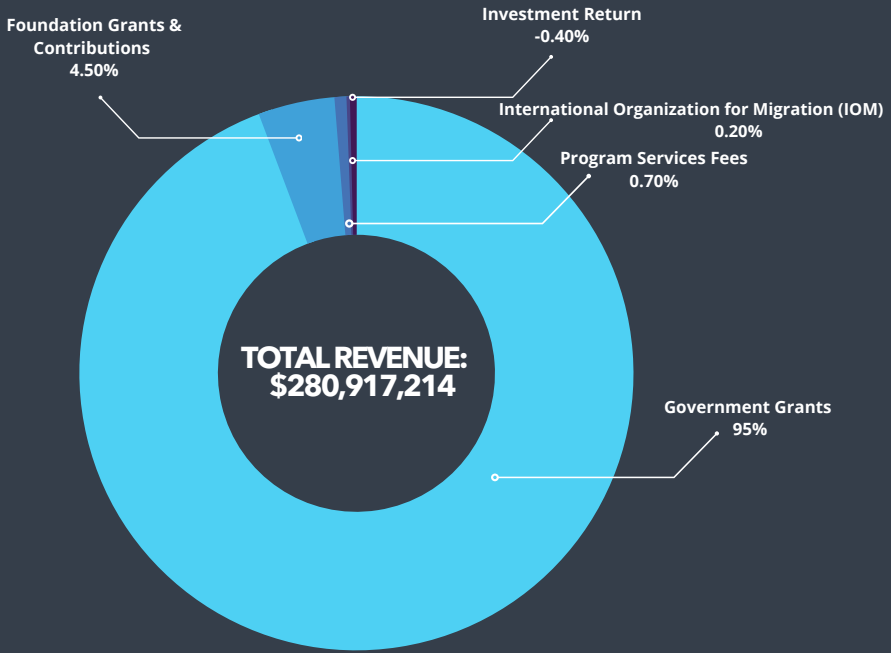

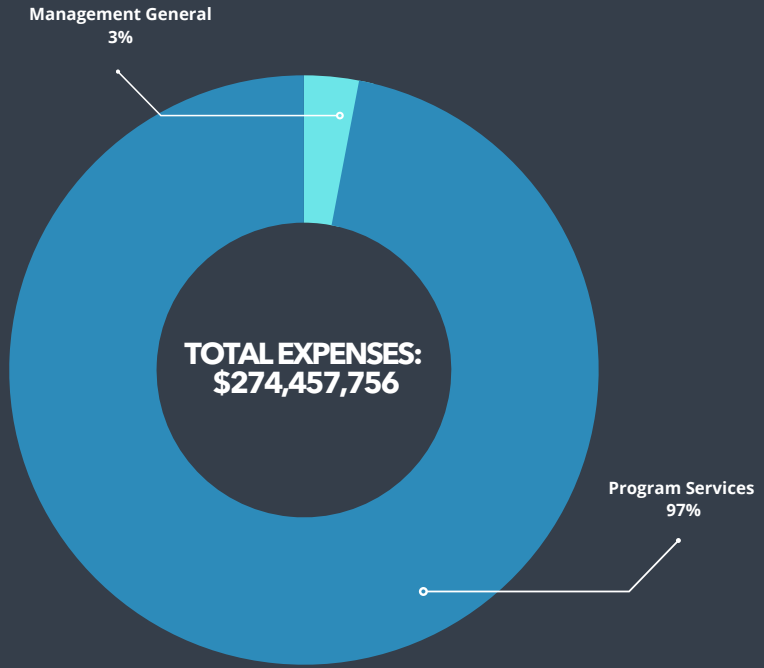
